Meeting Minutes Mar 7, 2022 Garwin City Council

Mayor Untiedt called the meeting to order at 6:00pm and took roll call: Deam, Meling, Brave Heart, McCubbin, and Zoffka.

Meling moved to approve the consent agenda, clerks report, minutes from 2/7/22, clerks report, bills Mar 7, 2022, McCubbin seconded. Motion passed 5-0.

Mayor Untiedt spoke regarding 4-wheelers being operated in town. Mayor asks for those with concerns regarding 4-wheelers to contact the Tama Co. Sheriff's Dept. Council declined Collins proposal of purchase, more information is needed for Garwin Codes, Bids, and other references.

Brave Heart motioned and Meling seconded to post part-time and an "as needed" part-time city maintenance positions. Motion passed 5-0.

Deam approve and Zoffka seconded setting public hearing for FY23 Budget for March 28 @ 6pm. Motion passed 5-0.

Council approved the writing of nuisance letters to all citizens of the community.

Holven, Fire Chief, reminded the council of their responsibility to the Fire Dept per 28E agreements.

Parks, AMB Dept, requested a donation from the City for Easter Egg Hunt. She also reminded the yearly mutual aid checks are to be written to the City of Toledo in the amount of \$2000.

Daniel, Water/Sewer Dept, the shelter house has had the sewer freeze up. Bids for repair are to be taken by: MD Construction, Hardons, and KB Construction.

No report from Finance Dept

McCubbin, Parks & Library Dept, gave library report. It was discussed, the shelter house rental should have a contract and checklist to abide by.

Deam, Sewer & Fire Dept, suggested, City hall to pay 33% of Alliant bill for use of the Fire Dept space.

Zoffka, Water & Ordinances Dept., Deam motioned and Brave Heart seconded Gossard sewer credit. Motion passed 4-1 Meling voting no. Amendment of Ordinance #92 Water, first reading will be 4/2/22.

Brave Heart, Streets, the city will be accepting applications for city maintenance.

Cindy Upah for Music in the Park spoke. Meling motioned and McCubbin seconded spending \$1750 for bands. Motion passed 5-0.

Deam motioned Brave Heart seconded to schedule next meeting 4/4/2022
