Deam motioned and Meling seconded to approve Resolution 2022-04 - Naming Depositories. Motion passed 5-0.

No motion was taken to approve amending FY22 budget water enterprise fund or approving use of ARPA funds for water project or transferring ARPA funds to water project or to set a public hearing for the above.

Nothing to report: Mayor, Fire Dept, Ambulance, Water, Finance, Sewer, Zoning, Sheriff report was included in council packets.

The Methodist Church has an Ash tree that was to be cut down due to Emerald Ash Bores. Deam will check with Alliant about this tree and 2 others on 4th St. Matt Garber who was in attendance will review his records regarding these trees as well.

Meling motioned and Zoffka seconded to approve abatement services by Junk Relief. Motion passed 5-0.

Melling motioned and Brave Heart seconded to approve assessing fees incurred by Junk Relief to the property owner where abatement will take place. Motion passed 5-0.

230 Main St had a nuisance to report however, this nuisance is between property owners and would be a civil matter.

The council again requested nuisance letters be sent out to those who are in violation.

McCubbin reporting for the library; the Library Director has put in for her retirement 6/6/22. The library has had estimates done for the basement walls.

Zoffka motioned and Deam seconded amending Ordinance Chapter #92 second reading and to waive the 3rd reading. Motion passed 5-0.
