Brave Heart motion and Zoffka seconded to approve application for 201 Park St for ground mounted solar panels upon receiving the \$25 building permit fee. Motion passed 5-0.

Deam motioned and Brave Heart seconded to approve State of Iowa Alcoholic Beverage Division for Garwin Bull under Donnie Ebrecht. Motion passed 4-1 with McCubbin abstaining.

Deam motioned and Zoffka seconded to table 2022 Bridge Inspection until Aug 1, 2022 meeting. Motion passed 5-0.

Meling motioned and Deam seconded to approve Budget Amendment to FY 22 Resolution 2022-6. Motion passed 5-0.

Clapsaddle-Garber Completion of watermain project with Morris enterprises was postponed for correction to Resolution 2022-7.

Codification of Ordinance were tabled. Clerk will bring more information to Council at next meeting 7/11/22.

Deam motioned and Brave Heart seconded to assess \$2250.00 of Junk Relief charges to Stanley/Marchman Property. Motion passed 5-0.

Holven, Fire Chief, spoke about fire at 506 Center St, it is under full IDNR investigation. July 2, 2022 Fire Dept will have a hog roast, Lions club will serve breakfast, a tractor show, and there will be fireworks. Holven question if it were an option to put broke up cement pieces along the creek by the lagoons. Council said to get ahold of Randy Daniel as that is his department. Holven also reported for Ambulance dept. they purchased bike helmets for the 3rd grade classes at GMG.

Meling reported the city needs to meter their own water use as well as the citizens. Check with Randy Daniel.
