CHAPTER 65
 STOP OR YIELD REQUIRED

65.01 THROUGH STREETS - STOP. Every driver of a vehicle shall stop, unless a yield is permitted by this chapter, before entering an intersection with the following designated through streets.

(Code of Iowa, Sec. 321.345)

1. Center Street from First Street to the east corporate limits;
2. First Street from High Street to Center Street.

65.02 SPECIAL STOPS REQUIRED. Every driver of a vehicle shall stop in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. Main Street. Vehicles traveling west on Main Street shall stop at Second Street;
2. Front Street. Vehicles traveling on Front Street shall stop at Main Street;
3. First Street. Vehicles traveling south on First Street shall stop at Center Street;
4. Rider Street. Vehicles traveling east on Rider Street shall stop at the County Road at the east corporate limits;
5. Park Street. Vehicles traveling west on Park Street shall stop at First Street;
6. Anna Street. Vehicles traveling west on Anna Street shall stop at First Street;
7. Rider Street. Vehicles traveling west on Rider Street shall stop at First Street;
8. High Street. Vehicles traveling west on High Street shall stop at First Street;
9. Walnut Street. Vehicles traveling east on Walnut Street shall stop at County Road T-47;
10. Second Street. Vehicles traveling on Second Street shall stop at Center Street;
11. Fourth Street. Vehicles traveling on Fourth Street shall stop at Center Street;
12. Rider Street. Vehicles traveling on Rider Street shall stop at Fourth Street;
13. Maple Street. Vehicles traveling on Maple Street shall stop at Fifth Street.
14. Front Street. Vehicles traveling on Front Street shall stop at Center Street.

15. Rider Street. Vehicles traveling on Rider Street shall stop at Second Street;
16. Maple Street. Vehicles traveling on Maple Street shall stop at Fourth Street;
17. Anna Street. Vehicles traveling on Anna Street shall stop at Second Street;
18. Anna Street. Vehicles traveling on Anna Street shall stop at Third Street;
19. Anna Street. Vehicles traveling east on Anna Street shall stop at Fourth Street;

- 20. Park Street. Vehicles traveling on Park Street shall stop at Second Street;
- 21. Park Street. Vehicles traveling on Park Street shall stop at Third Street;
- 22. Park Street. Vehicles traveling east on Park Street shall stop at Fourth Street.

- 23. Rider Street. Vehicles traveling on Rider Street shall stop at Third Street;
- 24. Third Street. Vehicles traveling north on Third Street shall stop at Rider Street;
- 25. County Road T-47. Vehicles traveling east on County Road T-47 shall stop at Front Street.

- 26. Fourth Street. Vehicles traveling on Fourth Street shall stop at Rider Street;
- 27. Fourth Street. Vehicles traveling on Fourth Street shall stop at Anna Street.

65.03 FOUR-WAY STOP INTERSECTIONS. Every driver of a vehicle shall stop before entering the following designated four-way stop intersections:

(Code of Iowa, Sec. 321.345)

- 1. Intersection of Center Street and Third Street;
- 2. Intersection of Main Street and Third Street.

65.04 SPECIAL YIELD REQUIRED. Every driver of a vehicle shall yield in accordance with the following:

(Code of Iowa, Sec. 321.345)

- 1. Third Street. Vehicles traveling south on Third Street shall yield at Front Street;
- 2. Park Street. Vehicles traveling east on Park Street shall yield at Third Street;
- 3. Park Street. Vehicles traveling on Park Street shall yield at Second Street;
- 4. Maple Street. Vehicles traveling east on Maple Street shall yield at the County Road at the east corporate limits;
- 5. Fourth Street. Vehicles traveling north on Fourth Street shall yield at Main Street.

65.05 SCHOOL STOPS. At the following school crossing zones every driver of a vehicle approaching said zone shall bring the vehicle to a full stop at a point ten (10) feet from the approach side of the crosswalk marked by an authorized school stop sign and thereafter proceed in a careful and prudent manner until the vehicle shall have passed through such school crossing zone.

- 1. Third Street, at a point halfway between Park Street and Anna Street;
- 2. Fourth Street, at a point halfway between Park Street and Anna Street.

65.06 STOP BEFORE CROSSING SIDEWALK. The driver of a vehicle emerging from a private roadway, alley, driveway, or building shall stop such vehicle immediately prior to driving onto the sidewalk area and thereafter shall proceed into the sidewalk area only when able to do so without danger to pedestrian traffic and shall yield the right-of-way to any vehicular traffic on the street into which the vehicle is entering.

65.07 STOP WHEN TRAFFIC IS OBSTRUCTED. Notwithstanding any traffic control signal indication to proceed, no driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk to accommodate the vehicle.

65.08 YIELD TO PEDESTRIANS IN CROSSWALKS. Where traffic control signals are not in place or in operation, the driver of a vehicle shall yield the right-of-way, slowing down or stopping, if need be, to yield to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection.

65.09 PARKING AND TRAFFIC RESTRICTIONS. No through traffic or parking on Park Street between 3rd and 4th Street during the hours of 7:30-8:30 a.m. and 3:00-4:00 p.m. Monday through Friday. Parallel parking only on the east side of 4th Street between Park Street and Anna Street Monday through Friday.

65.10 TRAFFIC RESTRICTIONS. No U-turns will be allowed on Front Street between Center and Carlton Street.
